### SPINK COUNTY COMMISSION PROCEEDINGS REDFIELD, SOUTH DAKOTA

The Spink County Board of Commissioners met at 8:30 AM on Tuesday, September 11, 2012, at the Spink County Courthouse. Present were Commissioners Dave Albrecht, Jeff Albrecht, Brian Johnson, Craig Johnson and Jerry Zerbel.

Pat Kramp, Commissioner Elect, was present to observe the meeting.

#### ADOPT AGENDA

Motion was made by C. Johnson, seconded by B. Johnson, to adopt the agenda with the additions of an E911 equipment transfer, Theresa Hodges, Welfare Director, and two plat resolutions. All members voted aye. Motion carried.

#### MINUTES APPROVED

Motion was made by B. Johnson, seconded by J. Zerbel, to approve the minutes of September 4, 2012. All members voted aye. Motion carried.

### **COUNTY WELFARE**

Theresa Hodges, Welfare Director, explained that an added claim had been received for client #198 who was granted prior approval on 4/10/12.

#### **CLOSING OFFICES**

Commissioners gave permission for Courthouse Offices to be closed while staff attends Homecoming Parade on Friday, September 14 from approximately 2:00 PM to 3:00 PM.

### **EECBG GRANT**

Eric Senger, Northeast Council of Governments, has looked over the Commissioners' request for additional funding from the Energy Efficiency Conservation Block Grant Agreement and recommended that it be submitted. Spink County was previously approved for 50% funding and may be able to recover all or a part of the County's share and/or of the cost overage.

### **STATES ATTORNEY**

Vic Fischbach, States Attorney, stated that he will look over information provided by the Auditor regarding the Social Services office space contract and get back to the Commission with a recommendation.

## **HIGHWAY SUPERINTENDENT**

Jeff Haessig filed bid specs for a 2013 or newer motor grader which is requested in the 2013 Highway budget. Motion was made by J. Albrecht and seconded by C. Johnson to advertise on September 19 & 26, 2012 for bids to be opened on October 2, 2012 for one (1) or more new 2013 or newer motor grader. All members voted aye and motion carried.

Full specs are on file in the offices of the County Highway Department and County Auditor. Delivery is expected between 1/2/13 and 1/15/13.

Haessig reported that when the Department has completed work on areas north of Doland the FEMA restoration will be completed. \$501,000 has been submitted for work on Federal Aid roads and the County has gotten \$155,000 back. Haessig expects to receive an estimated \$250,000 yet this year.

Commissioners are in agreement that more gravel may be crushed this year.

### **GROUP HEALTH INSURANCE**

Tim Kattke, DakotaCare, Kevin Schurch, Sheriff, and Theresa Hodges, Deputy Auditor, were present for the group health insurance renewal. Schurch expressed concern regarding the renewal coverage, which doesn't include co-payment benefits. Following discussion a motion was made by B. Johnson and seconded by C. Johnson to renew the Dakotacare contract with Kattke Insurance, Redfield, SD, for group health coverage from October 1, 2012 through September 30, 2013, and employees may choose

between \$2,000, \$3,000 or \$5,000 deductibles, each with 70/30 co-pay, a three tier rate for prescription coverage and Flex Plan benefits. All members voted aye. Motion carried.

#### SPINK COUNTY/REDFIELD CITY LAW ENFORCEMENT AGREEMENT

Kevin Schurch, Sheriff, discussed the results of a meeting between himself, several Redfield City Officials and County Commissioners Brian Johnson and Craig Johnson. They are making updates to the Law Enforcement Contract between Spink County and Redfield City.

# **BUDGET**

Commissioners discussed the 1.083% growth in Spink County last year, which will allow an approximately \$14,000 levy increase over last year's growth.

#### **PLANNING & ZONING**

At 10:00 AM a motion was made by J. Albrecht and seconded by Zerbel to recess as a Board of County Commissioners and convene as a Planning and Zoning Board. All members voted aye. Motion carried.

At 11:15 AM the Board of Spink County Commissioners reconvened following adjournment as a Planning & Zoning Board.
